The Townes is one of eight Sub associations tied to a single Master Association; PCA (Prestbury Citizen's Association). This structure is designed to create a relationship between the Master and the Sub associations that will benefit everyone involved. Simply said, the Master shares with the Subs the use of amenities such as a swimming pool, tennis courts, club house, etc. and in return each sub agrees to pay an assessment to help defray the operational costs of the master. Landscaping News

The Board and LCM Landscaping have had discussions on possible ideas for landscaping the strips between driveways.

These areas have traditionally been difficult to maintain and beautify. The pictures at right are a few suggestions submitted by LCM. Cost of landscaping would be paid by homeowners but LCM will install and provide the plants.

Costs below are ESTIMATES based on plants shown in pictures. Actual cost will depend on factors such as length of area, total square footage, shrubs vs. perennials, and existing day lilies being and transplanted to driveway strips
